RESULTS OF THE ANNUAL GENERAL MEETING HELD ON 1 JUNE 2015 (as audited by KPMG)

The fifth annual general meeting of the Trust was held on 1 June 2015 and was attended by the requisite quorum of members (529 members in person or by proxy holding 424 213 votes).

- 5. The remuneration of the Trustees for the period 1 July 2015 to 30 June 2016 was approved by the required majority (requirement 75% of votes cast):

 - 5.2 Remuneration of the Deputy Chairman of the board, being a retainer of R232 000 and an attendance fee of R11 200 per meeting (95.82% in favour);
