Terms and Conditions

- One or more universities may be eligible for refurbishment depending on the cost of the refurbishment within the budget allocated from time to time by the PPS Insurance Board.
- PPS will be guaranteed the naming rights to the refurbished facility for a period of 24 months and the costs associated to such naming rights will be borne by the sponsored entity.
- PPS will be entitled at any stage in the future to withdraw its name from each or any of the facilities.
- An opening function of the refurbished facilities is to take place to acknowledge the sponsorship.
- Any cost of the refurbishment exceeding the amount approved by PPS will be for the account of the applicant.
- The closing date for submission of applications is 31 December 2011. Successful applicants will be notified by the end of January 2012.
- The judges' decision is final and no correspondence will be entered into.
- A cheque handover ceremony is to take place for amounts of R50 000 or more.
