FUND DESCRIPTION

This fund typically invests in interest-earning securities, such as negotiable certificates of deposit, variable rate bonds and fixed deposits. It may invest in listed or unlisted financial instruments. All underlying investments are domestic only and therefore denominated in rands It may also hold units in collective investment schemes or other similar schemes.

The PPS Enhanced Yield fund aims to provide investors with income in excess of its benchmark, while providing capital protection with a short duration and maintaining a high degree of liquidity. This fund is managed according to Regulation 28 of the Pension funds Act and therefore is a suitable standalone vehicle for retirement savings.







FUND COMMENTARY

This fund is suitable for investors seeking a cash-plus return and is conservatively managed.

The vaccination drive was still rolling out slowly over the quarter and the concerns of a third wave was manifested by the increase to alert level four and more stringent lockdown rules for local businesses. Inflation ticked up above the midpoint of the target band, albeit still within the band. While this increased the likelihood of an interest rate hike in 2021, it was largely expected that inflation would increase due to base effects as the lockdown was still highly restrictive 12 months ago.

Over the one year investment horizon SA nominal bonds in total were up 13.7%, while short dated bonds were up 4.9% and long dated bonds were up 17.9%. Inflation-linked bonds continued to perform well with a 14.8% return for the year. Cash delivered a return of 3.5%, which has been declining over time, in line with short term rate cuts. As the fund targets a cash-plus risk and return profile the underlying investments are all linked to Jibar which resets after 90 days, even though they have longer maturities. The conservative approach results in a fund with very low duration and low volatility.

For the quarter the fund returned 1.2% which outperformed the benchmark but slightly underperformed the peer group average. This was similar over the one year investment horizon as the cautious approach has been maintained. The fund duration remains low at less than 2 months and investors can rely on a consistent level of performance with very little volatility regardless of interest rate movements.

DISCLOSURES

Portfolio valuations occur at 3 p.m. on business days, except the last business day of the month, when it will be 5pm. Prices are published daily and are available in the daily newspapers.

A schedule of fees, charges and maximum commissions are available on request. This fund does not charge performance fees.

The manager may close the portfolio to new investors to ensure the portfolio is managed according to its mandate.
