#### WHAT IS THE FUND'S OBJECTIVE?

Strategic Income aims to achieve a higher return than a traditional money market or pure income fund.

#### WHAT DOES THE FUND INVEST IN?

Strategic Income can invest in a wide variety of assets, such as cash, government and corporate bonds, inflation-linked bonds and listed property, both in South Africa and internationally.

As great care is taken to protect the fund against loss, Strategic Income does not invest in ordinary shares and its combined exposure to locally listed property (typically max. 10%), local preference shares (typically max. 10%), local hybrid instruments (typically max. 5%) and international assets (typically max. 10%) would generally not exceed 25% of the fund.

The fund has a flexible mandate with no prescribed maturity or duration limits for its investments. The fund is mandated to use derivative instruments for efficient portfolio management purposes.

Strategic Income is tactically managed to secure an attractive return, while protecting capital.

Its investments are carefully researched by a large and experienced investment team and subjected to a strict risk management process. The fund is actively positioned to balance long-term strategic positions with shorter-term tactical opportunities to achieve the best possible income.

While the fund is managed in a conservative and defensive manner, there are no guarantees it will always outperform cash over short periods of time. Capital losses are possible, especially in the case of negative credit events affecting underlying holdings.

#### HOW LONG SHOULD INVESTORS REMAIN INVESTED?

The recommended investment term is 12-months and longer. The fund's exposure to growth assets like listed property and preference shares will cause price fluctuations from day to day, making it unsuitable as an alternative to a money market fund over very short investment horizons (12-months and shorter). Note that the fund is also less likely to outperform money market funds in a rising interest rate environment.

Given its limited exposure to growth assets, the fund is not suited for investment terms of longer than five years.

#### WHO SHOULD CONSIDER INVESTING IN THE FUND?

Investors who

- are looking for an intelligent alternative to cash or bank deposits over periods from 12 to 36 months;
- seek managed exposure to income generating investments;
- are believers in the benefits of active management within the fixed interest universe.

#### WHAT COSTS CAN I EXPECT TO PAY?

An annual fee of 0.45% (excl. VAT) is payable.

Fund expenses that are incurred in the fund include trading, custody and audit charges. All performance information is disclosed after deducting all fees and other fund costs.

We do not charge fees to access or withdraw from the fund.



Quarterly Portfolio Manager Commentary



#### Please note that the commentary is for the retail class of the fund.

The fund returned 0.8% in January, bringing its total return to 7.8% for the 12-month period. This is ahead of the returns delivered by cash (6.9%) and its benchmark (7.6%) over the same one-year period.

Local bonds delivered a mediocre performance in January. The All Bond Index was up 1.19% for the month, with 3-7-year bonds delivering the best return of 1.95%. Bonds with 7-12-year maturities were up 1.11% and the long end of the curve ,12+ years, delivered 0.87%. Inflation-linked bonds performed poorly, returning -0.08%. Cash remained stable at 0.55%. Given the improvement in global risk sentiment, this lacklustre performance suggests some investor caution about South African fixed-income assets.

Available data shows a synchronised slowing in global growth through 2019, owing in part to the escalation in global trade tensions. With the conclusion of a Sino-USA Phase 1 trade agreement in mid-January, increased monetary accommodation by developed market central banks has helped support some tentative signs of improving activity into year end and into early 2020. However, the emergence of the Coronavirus remains a considerable risk to growth momentum, notably, but not limited to China.

In the US, final GDP for the fourth quarter of 2019 (Q4-19) came in at 2.1% quarter on quarter (q/q) and final GDP growth for 2019 was 2.3% year on year (y/y) vs 2018's 2.9%. Activity data remains mixed, with private sector demand, consumer spending and capex coming in on the weak side, despite tight labour market conditions. Net exports and government spending boosted growth. The quid pro quo Phase 1 trade agreement saw the US commit to decreasing the tariffs applied to Chinese goods and putting on hold future planned tariffs in exchange for a commitment by the Chinese to increase imports of selected goods and commodities. Headline inflation increased to 2.30% y/y in December versus November's 1.8% y/y print. Prices of core goods and services were flat, but energy prices increased by 3.4% y/y, contributing to the uptick in inflation. The Federal Reserve Board is expected to keep interests on hold for the year, as the personal consumption expenditure deflator continues to print below the inflation target of 2%.

In emerging markets, Chinese annual GDP growth slowed to 6.1% in 2019 versus 6.6% in 2018. The low number was a result of low consumption levels and the impact of ongoing trade tensions with the US. Net exports and government spending, however, contributed positively to growth. The economic impact of the outbreak of the Coronavirus is as yet unclear, although growth expectations have broadly been revised lower and the policy response has intensified, with accelerated People's Bank of China cutting rates, and the recent announcement that China would cut some of the tariffs on US goods that were imposed in 2019. Headline inflation remained unchanged at 4.5% y/y in December, with food (pork) prices the main contributor. Overall inflation for 2019 came in at 2.1%, printing below the government's target of 3%. Producer input costs have been in deflation since June and remain an anchor to headline consumer prices. The rand gave up all its gains and more in 2019, as it was down 6.7% in January ending at US\$1/R15.03. The combination of the risk-off environment caused by the Coronavirus and poor local fundamentals weighed heavily on the local unit. In addition, newsflow during January, which included more load shedding, soured sentiment towards SA even further. The fund maintains its healthy exposure to offshore assets and when valuations are stretched, will hedge/unhedge portions of its exposure back into rands/dollars by selling/buying JSE-traded currency futures (US dollars, UK pounds and euros). These instruments are used to adjust the fund's exposure synthetically, allowing it to maintain its core holdings in offshore assets. This has the added benefit of rand weakness, enhancing the fund's yield when repatriating exposure. Offshore exposure remains the best protection for rand investors in the event of a risk-driven sell-off.

The South African Reserve Bank (SARB)'s Monetary Policy Committee (MPC) met in January and unanimously voted to cut the repo by 25 basis points (bps) from 6.50% to 6.25%. The decision to cut the repo rate was attributed to persistently weak growth and a balanced inflation risk outlook. The country's deteriorating fiscal position and slow policy reform implementation remain a concern for the central bank. This may inhibit a faster pace of rate cutting than might have been the case if the government's finances were more stable. Furthermore, the central bank revised its inflation forecast down for 2020. from 5.1% to 4.7%.

Headline inflation printed at 4.0% y/y in December versus 3.6% y/y in November, and core inflation came in at 3.8% y/y in December versus November's 3.9% y/y. Overall, annual inflation for 2019 averaged 4.1% from 4.6% in 2018; comfortingly below the SARB's target range midpoint. Food inflation remains benign, and low rental inflation should help keep CPI well within target in 2020. Transport costs are expected to increase in the first half of 2020, before stabilising by year end.

At the end of December, shorter-dated fixed-rate negotiable certificates of deposit (NCDs) traded at 7.38% (three year) and 7.775% (five year); quite a bit lower than the previous month. The spreads of floating-rate NCDs have dulled in appeal over the last few quarters due to a compression in credit spreads. There has been a reduced need for funding from banks in South Africa, given the low-growth environment. Fixed-rate NCDs continue to hold appeal due to the inherent protection offered by their yields and relative to our expectations for a stable repo rate. However, credit spreads remain in expensive territory (less than 100bps in the three-year area and 110bps in the five-year area). The fund continues to hold decent exposure to these instruments (less floating than fixed), but we will remain cautious and selective when increasing exposure. NCDs have the added benefit of being liquid, thus aligning the liquidity of the fund with the needs of its investors.

The SA economy has been plagued with low growth, ballooning government finances and a volatile global geopolitical environment. Low growth and well contained inflation suggest the trajectory for SA policy rates to be lower over the next 12 months. In addition, SA bonds have continued to underperform relative to their global and emerging market counterparts, suggesting an increased risk premium given SA's precarious economic backdrop. At current levels, South African government bonds (SAGBs) seem adequately priced relative to underlying risks, which suggest a neutral allocation in portfolios.

The local listed-property sector was down 3.3% over January, bringing its return for the rolling 12-month period to - 9.5%. Listed property has been the largest drag on the fund's performance, primarily due to idiosyncratic domestic issues relating to the pressure on tenant profitability as a result of lower GDP growth, which has had an unfavorable impact on the broader property sector. Despite the underperformance, from a valuation perspective, the sector remains very attractive. If one excludes offshore exposure, the property sector's yield is greater than 10%, which compares very favourably to the benchmark bond. The fund maintains holdings in counters that offer strong distribution and income growth, with upside to their net asset value. In the event of a moderation in listed property valuations (which may be triggered by further risk-asset or bond-market weakness), we will look to increase the fund's exposure to this sector at more attractive levels.

The FTSE/JSE Preference Share Index was down 0.8% over January, bringing its 12-month return to 16.7%. Preference shares offer a steady dividend yield linked to the prime rate and, depending on the risk profile of the issuer, currently yield between 9% and 11% (subject to a 20% dividends tax, depending on the investor entity). The change in capital structure requirements mandated by Basel III will discourage banks from issuing preference shares. This will limit availability. In addition, most of the bank-related preference shares trade at a discount, which enhances their attractiveness for holders from a total return perspective and increases the likelihood of bank buybacks. Despite attractive valuations, this asset class will continue to dissipate, given the lack of new issuance and because it risks being classified as eligible loss-absorbing capital (only senior to equity). The fund maintains select exposure to certain high-quality corporate preference shares, but will not actively look to increase its holdings.

We remain vigilant of risks emanating from the dislocations between stretched valuations and the underlying fundamentals of the local economy. However, we believe that the fund's current positioning correctly reflects appropriate levels of caution. The fund's yield of 8.25% remains attractive relative to its duration risk. We continue to believe that this yield is an adequate proxy for expected fund performance over the next 12 months.

As is evident, we remain cautious in our management of the fund. We continue to invest only in assets and instruments that we believe have the correct risk and term premium to limit investor downside and enhance yield.

#### HOW ARE UNITS PRICED AND AT WHICH PRICE WILL MY TRANSACTION BE EXECUTED?

Unit trusts are traded at ruling prices set on every trading day. Fund valuations take place at approximately 15h00 each business day, except at month end when the valuation is performed at approximately 17h00 (JSE market close) and forward pricing is used. Instructions must reach the Management Company before 14h00 (12h00 for the Money Market Fund) to ensure same day value. The payment of withdrawals may be delayed in extraordinary circumstances, when the manager with the consent of the fund trustees deem this to be in the interest of all fund investors. These circumstances may include periods when significant underlying markets suspend trading which will prevent accurate valuation of the instruments held in the fund. When the suspension of trading relates to only certain assets held by the fund, these assets may be side-pocketed. This process allows normal liquidity on the assets that can be valued, but will delay liquidity on the affected portion of the fund. If the fund is faced with excessive withdrawals, the affected withdrawals may be ring-fenced, which is the separation and delayed sale of the assets reflecting the interest of the liquidity seeking investors. It ensures that the sale of a large number of units will not force Coronation to sell the underlying investments in a manner that may have a negative impact on remaining investors of the fund.

## HOW WAS THE PERFORMANCE INFORMATION INCLUDED IN THIS FACT SHEET CALCULATED?

Performance is calculated by Coronation as at the last day of the month for a lump sum investment using Class P NAV prices with income distributions reinvested. Class A NAV prices were used for the period prior to the launch of Class P. All underlying price and distribution data is sourced from Morningstar. Performance figures are quoted after the deduction of all costs (including manager fees and trading costs) incurred within the fund. Note that individual investor performance may differ as a result of the actual investment date, the date of reinvestment of distributions and dividend withholding tax, where applicable. Annualised performance figures represent the geometric average return earned by the fund over the given time period. Unannualised performance represents the total return earned by the fund over the given time period, expressed as a percentage.

### WHAT IS THE TOTAL EXPENSE RATIO (TER) AND TRANSACTION COSTS (TC)?

TER is calculated as a percentage of the average net asset value of the portfolio incurred as charges, levies and fees in the management of the portfolio. The TER charged by any underlying fund held as part of a fund's portfolio is included in the fund expenses portion of the TER, but trading and implementation costs incurred in managing the fund are excluded. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER may not necessarily be an accurate indication of future TER's. The 1 year TER is for the 12 months to end of September 2019 (updated annually). The 3 year TER is for a rolling 36-month period to the last quarter end (December, March, June and September).

Transaction costs are a necessary cost in managing a fund and impacts the fund's return. They should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of fund, the investment decisions of the investment manager and the TER.

The Total Investment Charge is the sum of the Total Expense Ratio (TER) and transaction costs.
